## METODOLOGI OG METODER 2019/2020

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

To provide students with a sound understanding of the main components of a research project including the linkage between various methodological choices and research design. To give students further insight into a variety of social scientific research strategies, including qualitative and quantitative research designs and methods. To enable students to read and reflect critically upon various types of academic research designs. To enable students to select, describe and implement their own methodological choices and research strategies, and to communicate their choices in their own project writing.

Based on a sound understanding of the main components of a research project, students will explore various methodological choices including theory selection and concrete techniques of data selection, collection and analysis in qualitative research and to a certain extent in quantitative research. This will be applied in actual project work in modules 9 and 18. Emphasis will be on how students can translate these methods into their own practices. Furthermore, strong emphasis will be placed on discussing quality criteria in the contexts of both qualitative and quantitative research designs, in order to enable students to make well-founded and ethically sound choices in their own project work, and read academic research critically.

The module consists of lectures, exercises and student contributions.

# TEORIER OM INTERNATIONALE RELATIONER 2019/2020

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

- To provide students with knowledge on traditional theories of international relations (IR) such as realism or liberalism as well as theories of international political economy (IPE).
- To provide students with knowledge on new approaches to IR and IPE. This includes alternative theories as well as critical approaches, i.e. extended versions of traditional theories.
- To enable students to discuss key elements of IR and IPE theories in relation to empirical cases.

In the lectures, students will work with the history and development of the field. The main theoretical approaches to international relations will be presented and discussed. Furthermore, students will be introduced to alternative approaches. The module will form the basis for further theoretical and practical work within the field in the project module of the semester, cf. module 9.

### **PROJEKTMODUL I**

### 2019/2020

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

The objective of this module is:

- to provide students with additional factual and theoretical knowledge within the subject areas of modules 1-8, and to give them the opportunity to reflect on theories and their usability in specific contexts in a critical a manner.
- · to gather experience with empirical data collection and reflect on this
- · to gather experience in working in a team of people with different competences and cultural backgrounds
- · to practice working actively in an English-language project process
- to practice discussing potentially controversial issues while respecting other people's opinions
- to gain experience in collecting large quantities of data and information and processing it in order to solve a particular problem
- · to practise academic writing in English
- · to learn how to complete a project within a set deadline.

Students form groups and define a problem within modules 1 - 8. The group will work on the problem independently. The university provides academic supervision. Students must discuss various theories and select one or several, which they deem to be relevant. Unless it is a purely theory-based project, students must discuss which type of empirical data might be relevant in this context and organise the data collection. The topic of the project must be formulated as a problem, and students must seek to answer this problem. The answer must be based on theoretical reflection and – unless it is a purely theory-based project – be empirically grounded. Purely descriptive projects are not acceptable.

## NYE MAGTER OG NYE MARKEDER 2019/2020

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

This module will explore the different development paths of global rising powers and emerging markets, and examine the impact of the emerging powers on global markets and the current world order.

The objectives of this module are:

- To study different contemporary development trajectories and strategies in major emerging countries, with a special focus on the effect on the global economy and the transition to variations of market economy.
- To understand private sector development and the role of the private sector in national development and to examine the drivers and barriers for successful private sector development
- To examine the significance of rising powers and emerging markets and their impact on global markets, the global community and global governance

The module provides an approach to the study of emerging markets/rising powers based on a number of interrelated aspects such as national development strategies, state-market relations, the underlying institutions and policies, and the relationships between the rising powers and the rest of the world.

This approach provides an in-depth understanding of the possibilities and limitations of rising powers in relation to the impact on the international system and an understanding of the opportunities and challenges for other countries due to the rising powers and emerging markets.

The module will form the basis for further theoretical and practical work within the field in the project module of the semester, cf. the Project Module II.

Students will choose a problem based within modules anchored at 2nd semester and work on it independently. The University provides academic supervision. Unless it is a purely theory-based project, students must discuss which type of empirical data might be relevant in this context and organise the data collection. The topic of the project must be formulated as a problem, and students must endeavour to answer this problem. The answer must be based on theoretical reflection and – unless it is a purely theory-based project – be empirically grounded. Purely descriptive projects are not acceptable.

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

During the module students must spend a minimum of three months in an international organization working with activities related to development and international relations. There are two options for DIR students and three options for DIR/GRS students:

**Option 1:** An internship at an organization with activities within development and international relations. The host organization is chosen by the student and must be approved by the study board. Before the internship starts, an agreement between the student, study board and host organization must be drawn up stating the expectations and responsibilities of the student during the internship. This agreement will specify which tasks the student is expected to undertake at the host organization. In addition, students will be expected to produce a project report at the end of the internship on a topic of relevance to the host organization. The internship and the project report together correspond to a total of 25 ECTS credits.

**Option 2:** A study stay abroad at a university or research institution in collaboration with Aalborg University. Students must apply for advance approval of transfer credit from the study board before departure. Upon return, students must apply for credit transfer. Students must choose courses/seminars within the field of development studies and international relations amounting to a total of 30 ECTS.

#### Option 3 (only applies for students specializing in Global Refugee Studies):

A study period at Aalborg University Copenhagen within the subject area of Mobilities, Social Change and Development. The course comprises four modules (the modules Transnational Mobilities as Agents of Change, Ethics in Tourism and Ethical Development and Mobilities, Development and Diaspora and Project Work within Mobilities, Social Change and Development; three course modules of 5 ECTS credits each (a total of 15 ECTS) and a project module of 15 ECTS credits. See the descriptions of the modules.

### Choice of specialization

If students have opted for a full specialization within Chinese Area Studies, Latin American Area Studies or Global Gender Studies, the internship/study stay abroad must be related to the chosen specialization.

Students who have opted for a full specialization within Global Refugee Studies may choose between options 1, 2 or 3. If students choose option 1 or 2, the focus must be within Global Refugee Studies.

#### **Objectives (option 1)**

The objective of the module is that students gain practical experience through applying knowledge, theories and methods within development and international relations while working in an international organization. Moreover, the students must be able to reflect critically on their experience during their time at an international organization and on the linkage between their study programs and the internship.

#### **Contents (option 1)**

During the module, students must spend a minimum of three months at an organization working within the fields of development and international relations. Concurrently, the students will write a project report, reflecting on their experience and using their theoretical knowledge about Development and International Relations to identify and analyze a problem field of relevance to the host organization.

## GLOBALE KØNSSTUDIER 2018/2019

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

#### **Objectives:**

To provide students with knowledge about and insight into gender theories and how these can be used in analyses of inequalities within the field of development policy and international and transnational relations.

#### Content

The course will give an introduction to the area of 'gender and globalisation', in particular in the context of development and international relations, and will include discussions of specific cases and case studies in which gender and equality can be understood from local, regional and global perspectives (including the EU as a regional institution). Specific emphasis will be placed on the history of gender and equality policy within the field of development and international relations, on possibilities and limitations of international law and human rights, and on analyses of gender and equality policies in various contexts and parts of the world, which are relevant areas of research within development and international relations. The module will form the basis of further theoretical and practical work within the field in the project module of the semester,

# KØNSPERSPEKTIV PÅ GLOBAL GOVERNANCE 2018/2019

### MODULETS INDHOLD, FORLØB OG PÆDAGOGIK

#### **Objectives:**

This course aims to enhance students' knowledge of global governance and global democracy through the study of the role of social movements (social movement organisations/non-governmental organisations) and analysis of (international) institutions, (gender) policies and transnational activism.

#### Content

Students will be introduced to the aspects of gender in global governance and global democracy, and governance will be discussed from 'top-down', 'bottom-up' and transnational perspectives. *Firstly,* governance of gender inequalities at the transnational level will be analysed with a focus on international institutions and policies. On this basis, theories of (feminist) institutionalism and international and European legislation and policies will be analysed. These theories will underpin a critical discussion of the 'gendered infrastructure' and history of global relations in the context of the international organisations' specific agencies for gender relations such as The European Institute for Gender Equality (EIGE) and UN Women.

Secondly, focus will be on a critical discussion of the mobilisation of social movements in various parts of the world and on the interaction between the (global) civil society, international institutions, international law in the Global North and the Global South and the emerging powers/economies in Asia, Africa and Latin America. This will include theories on the aspects of gender in concepts such as citizenship, the global civil society, transnational solidarity and postcolonialism. The module will form the basis of further theoretical and practical work within the field in the project module of the semester.
