ART AND PROBLEM-BASED RESEARCH METHODOLOGY

2023/2024

CONTENT, PROGRESS AND PEDAGOGY OF THE MODULE

This module gives knowledge of theories and methods for creating art-based, visual communicative, digital and cultural expertise. The students are taught problem-based, art based and art pedagogical approaches to research and theory generating practice. The module comprises local based and site-specific activities connected to art and problem-based research methodology. First part of the module is taking place as a five-days mandatory symposium on one campus.

LEARNING OBJECTIVES

KNOWLEDGE

Through the module, the student must gain knowledge and understanding of:

- Visual communicative, digital and cultural paradigms, methodologies and art-based methods
- · Relation between scientific philosophy, scientific and art-based methods and theory in transdisciplinary settings
- Problem-based, art-based, art pedagogical approaches to research and theory generating practices

SKILLS

The student must through the module acquire skills in:

- Seeking, analysing, and discussing advanced research literature in art education, digital visual communication, and arts-based research
- · Applying theories and concepts from advanced research literature and practice in independent research projects
- Evaluating and reflecting the implications from using diverse methodical, artistic and theoretical approaches and concepts

- Independently to perform creative problem setting, rethink, plan and conduct and problem-solving in specific contexts of practice
- Reflect on the basis for combining creative and scientific approaches for investigating visual communicative and art educational issues

INTERVENTIONS FOR CHANGE IN COMMUNICATION AND ART PEDAGOGICAL PRACTICES

2023/2024

CONTENT, PROGRESS AND PEDAGOGY OF THE MODULE

The project module provides knowledge and skills for planning and conducting a creative problem-solving project that can change and develop an existing practice in professional, organisational and/or digital media related contexts. Changes both trough and of visual and digital communication and of art pedagogical and cultural practice. The content focusses on analysis and design of meaning-making activities in different contexts and interactions. The module comprises also planning, conducting and communication of the project results to a broader audience like a conference, an event, an exhibition or an artefact. First part of the module is taking place as a five-days mandatory symposium on one campus.

LEARNING OBJECTIVES

KNOWLEDGE

Through the module, the student must gain knowledge and understanding of:

- · Theories about communicational and art-based change and interventions
- · Methods for analysis and evaluation of communicational and art-based change and interventions
- · Professional and scientifically practice and issues within the chosen topic

- Planning, conducting, and evaluating independent project with external stakeholders
- Applying and reconfiguring concepts and methods from visual communication and art education in project-orientated work

LONGTERM ACADEMIC INTERSHIP 2023/2024

CONTENT, PROGRESS AND PEDAGOGY OF THE MODULE

The module contains the practical reality of visual and digital communications- culture and educational practice in working life. The main component is an internship of minimum 13 weeks in a relevant company, organisation or institution where the student collaborates about a professional task drawing on NoVA related knowledge, skills and competences from the programme. The purpose is to provide concrete experience with and insight into work-life. The student writes a report (15 pages) that reflects the academic intern experience theoretical and methodical.

The project module revolves around an academic internship or a project and includes methodology, project management and supervision. The project module can form the empirical basis for the master thesis.

VISUAL PROJECT 2023/2024

CONTENT, PROGRESS AND PEDAGOGY OF THE MODULE

The module contains the practical experience of applying visual productive skills of visual and digital communications and/or visual culture and/or art education into real life context. The two components are a visual oriented project of minimum 6 weeks and 1-2 elective courses at the host university that support the project. The project is conducted together with a relevant company, organisation, or institution where the student collaborates about a professional task. The purpose is to provide concrete experience with and insight into professional projects. The student provides a visual product and writes a synopsis report (7 pages) that reflects the visual product in context theoretical and methodical.

The project module revolves around an internship or a project and includes methodology, project management and supervision. The project module can form the empirical basis for the master thesis.

Through the module, the student must gain knowledge and understanding of:

- How does methods and theories meet practice especially focusing on planning, conducting and evaluating a visual oriented project for a real-life context of visual and digital communications and/or visual culture and/or art education
